(b) Tree Applications (to undertake work on trees situated in a conservation area)

i) 22/0105/TTPO 63 Church Street T1 - Horse Chestnut - Fell We have inspected a

Great Wilbraham mature Horse Chestnut tree which

Cambridge is in severe decline due to multiple Ganoderma

fungus brackets at the base.

Please note that application 22/0086/TTPO was presented as a 5-day notice but this application has been rejected by the Tree Officer and replaced by this application.

The Parish Council wished to comment that it is sad to lose the Horse Chestnut tree and it would be nice to plant two trees as a replacement that tree officer considers appropriate.

21-22/125 To consider grant requests applications – The clerk circulated a grant application received from the Wilbrahams' Memorial Hall Trustees for Wilbrahams' Cricket Club for a wireless digital electronic scoreboard in the sum of £3,000. R Tippen explained that some time ago the Parish Council had approved the purchase of a scoreboard. However, due to concerns over the viability of the Cricket Club it was not purchased at that time. The Cricket Club is now flourishing, and the existing scoreboard has deteriorated. It was proposed by C Jackman seconded C Page and unanimously RESOLVED to approve the application in the sum of £3,000 for the purchase of the

The clerk circulated a grant application received from Wilbrahams' Memorial Hall & Recreational Ground Trustees for the replacement of trees located adjacent to Church Street for the sum of £300.

It was proposed by C Jackman, seconded C Page and unanimously RESOLVED to approve the application in the sum of £300 towards the cost of two new trees and removal of the old trees.

**21-22/126** To discuss the Parish Council's communication and available options – A discussion took place regarding the impact of social media. It was agreed that this agenda item be moved to the March meeting.

### 21-22/127 To discuss the Platinum Jubilee Commemorative Coins and 'Queen's Platinum Jubilee'

**Community Chest Funding** – C Page presented samples of the coins for consideration. Members agreed on their preferred option. C Page agreed to speak to the editors of the Warbler about the possibility of distributing the flyer requesting applications for children aged up to 16 resident in Great Wilbraham. The logistics of collecting forms requesting the coins was discussed. A deadline for returning the forms was agreed as 21<sup>st</sup> March. The clerk agreed to print the flyers and raise the purchase order for all the items once all information is collated.

It was suggested an application be submitted to the community chest to fund a commemorative bench. The clerk was asked to circulate bench options.
